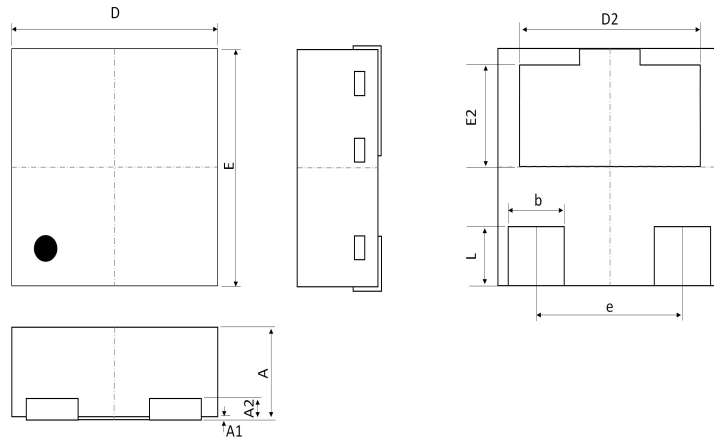

● Characteristic Curves



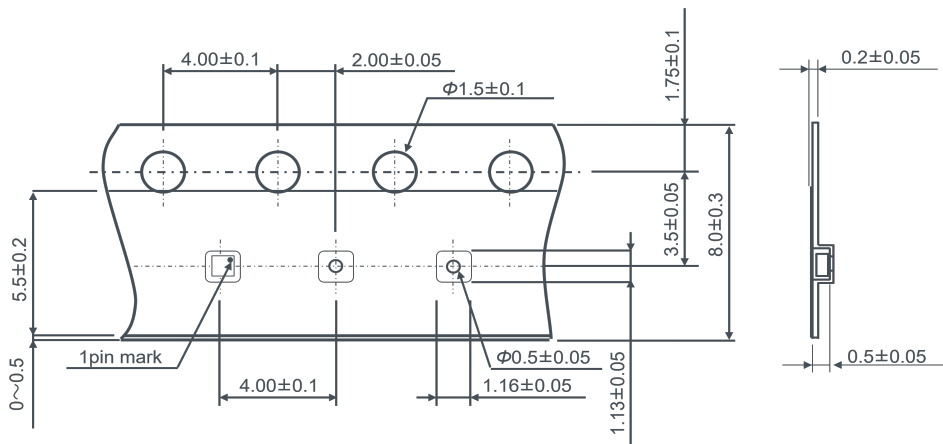
