








Fig.1 Ground Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector	



• Electrical characteristic curves ($T_a = 25^{\circ}C$)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current







Fig.8 Gain Bandwidth Product vs. Emitter Current




