



Features

Fig.1 Input Voltage vs. Output Current (ON Characteristics)





Fig.2 Output Current vs. Input Voltage (OFF Characteristics)

Fig.3 DC Current Gain vs. Output Current






Fig.4 Output Voltage vs. Output Current
