






Fig.3 Static Drain-Source On-State Resistance vs. Drain Current




Fig.5 Static Drain-Source On-State Resistance vs. Drain Current




Fig.2 Typical Output Characteristics ( II )




Fig.4 Static Drain-Source On-State Resistance vs. Drain Current




Fig.6 Forward Transfer Admittance vs. Drain Current




Fig.7 Typical Transfer Characteristics




Fig.9 Static Drain-Source On-State Resistance vs. Gate-Source Voltage




Fig.11 Dynamic Input Characteristics




Fig.8 Source Current vs. Source-Drain Voltage




Fig.10 Switching Characteristics





Fig.12 Typical Capacitance vs. Drain-Source Voltage

Fig.13 Normalized Transient Thermal Resistance v.s. Pulse Width





Fig.14 Maximum Safe Operating Area




Fig.1-1 Switching Time Measurement Circuit




Fig.2-1 Gate Charge Measurement Circuit




Fig.1-2 Switching Waveforms




Fig.2-2 Gate Charge Waveform
