






Fig.1 Power Dissipation Derating Curve







Fig.2 Maximum Safe Operating Area

Resistance vs. Pulse Width










Drain Current : -I_D [A]





Drain-Source Breakdown Voltage : -V_{(BR)DSS} [V]








Fig.8 Typical Transfer Characteristics

Fig.9 Gate Threshold Voltage vs. Junction Temperature




Fig.10 Forward Transfer Admittance vs. Drain Current






Fig.12 Static Drain - Source On - State Resistance vs. Gate Source Voltage





Fig.11 Drain Current Derating Curve





Fig.16 Static Drain - Source On - State Resistance vs. Drain Current(III)




Fig.18 Typical Capacitance vs. Drain -Source Voltage

Fig.19 Switching Characteristics




Fig.20 Source Current vs. Source Drain Voltage




